3. SRA approach to continuing competence

From November 2016 the SRA removed the requirement for solicitors to undertake 16 hours per year of CPD and has replaced this with a requirement for individuals to make an annual declaration confirming they have reflected on their practice and addressed any identified learning and development needs.

In October each year we will create a personalised Development Record for everyone who attends an EM Lawshare Training Course. Any reflections that you note on your feedback forms will be added to help you demonstrate compliance with the SRA regulations.

Equity, diversity and inclusivity are key to the success of local government organisations and positive action is one tool aimed at enabling employers to work towards improving diversity. Positive action was introduced by the Equality Action 2010, but employers have been cautious about relying on it to date. However, public sector employers, such as Councils must comply with the public sector equality duty. As such it is essential that you have due regard to advancing equality of opportunity and eliminating unlawful discrimination and in that respect, we will explore the potential use, and limits, of position action to achieve this.

There are two strands to positive action under the Equality Act:

- Section 158 general positive action which is permitted where it is reasonable for an employer
 to think that those with a protected characteristic suffer a disadvantage connected to the
 characteristic or have needs that are different or that participation in an activity by persons
 with the characteristic is disproportionately low; and
- Section 159 which permits the selection of a candidate with a protected characteristic for recruitment or promotion in a tie-break scenario if certain conditions are met.

Aley will go through the basics from a legal perspective, encourage an open discussion with attendees and will work through scenarios in breakout sessions to dispel the myths around positive action so you can be clear about how you can use it moving forward. They often follow complaints made by Guardians within care proceedings and have been made hand in hand with potential Human Rights Act claims. Local authorities have been bogged down with these claims for some years, waiting for certainty to be delivered by the Supreme Court.
